



**STUDENT CONTRACT**  
**CONTRACT DEADLINE – OCTOBER 31<sup>ST</sup>, 2008**

I, \_\_\_\_\_, do hereby acknowledge that, by using my seatbelt properly, and by encouraging others to do so, my actions could result in lives saved in the event I am in a vehicular crash. I also understand that Operation Cool has been created to help me and other students, throughout Illinois, learn this valuable safety habit.

Further, I hereby acknowledge that by signing this agreement and abiding by the terms and conditions contained in it, I will become eligible to participate in a drawing conducted by Operation Cool (Tri-County Operation Cool, Inc.) to be held at a later date, in which I may win a grand prize of a new Mitsubishi automobile or other incentive prizes.

I agree that, in order to remain eligible to win any (the grand prize or any other prize or prizes) of the prizes in this drawing, I will abide by the following rules:

- 1) I will remain enrolled as a student at a high school that is participating in the Operation Cool Program with Tri-County Operation Cool, Inc. and I will abide by all school policies.
- 2) I will wear my seatbelt at all times while I am operating or riding as a passenger in a motor vehicle.
- 3) I will cause all passengers, in any vehicle I am driving, to wear their seatbelt at all times.
- 4) That my compliance with the above rules may be checked from time to time by law enforcement or school officials and that if it is determined by such officials that I have violated any of these rules, my name will be permanently withdrawn from the contest and I will be ineligible to win any prize in it.
- 5) That my name will be permanently withdrawn from this contest and I will be permanently ineligible to win any prize in it in the event that I am adjudicated guilty (upon a plea of guilty to the court, finding of guilty in court, verdict of guilty in court or stipulation of evidence or facts supporting such a charge to the court in which I am charged) of any offense defined in Section 11-501 of the Illinois Vehicle Code (DUI alcohol, DUI drugs, etc.) or a similar provision of any statute or ordinance of any jurisdiction where violation occurs during the term of this contract (regardless of the date of that adjudication).

I further understand and acknowledge that the Tri-County Operation Cool Board has the right to exclude anyone they feel doesn't meet the necessary criteria.

I further understand and acknowledge that in order to win a grand prize car in this contest, I must be a validly licensed driver under the laws of the State of Illinois, and if under the age of 18, have my parent's or guardian's written permission. If I have not yet reached the age of eligibility for a driver's license, but am otherwise qualified under the contest rules, I may be eligible to win an alternate prize.

I further understand and acknowledge that in the event I am declared the winner of the grand prize or any other prize in this contest, I will be responsible for any and all taxes and other official fees, costs and licenses imposed or required by law.
